GLOBAL PRIVACY POLICY

International Lease Finance Corporation (“ILFC,” “we” or “us”) is committed to protecting the privacy of the individuals we may encounter in conducting our business. “**Personal Information**” is information that identifies and relates to you. This Privacy Policy describes how we handle Personal Information in our possession.

1. Who To Contact About Your Personal Information

2. Personal Information That We Collect

Personal Information collected about you may include general identification and business contact information, such as:

- Name
- Address
- E-mail address
- Telephone and fax number
- Job title and department
- Your relationship to us (e.g., that you are an employee or other individual associated with a customer, business partner or service provider of ours)
- Other Personal Information you may provide to us

3. How We Use Personal Information

We use this Personal Information to:

- Communicate with you and others as part of our business.
- Provide and improve our customer services.

- Provide information about our products and services to you in your capacity as a representative of a customer, service provider or other business partner.
- Manage our infrastructure and business operations, and comply with internal policies and procedures, including those relating to auditing; finance and accounting; billing and collections; IT systems; data and website hosting; business continuity; and records, document and print management.
- Resolve complaints, and handle requests for data access or correction.
- Comply with applicable laws and regulatory obligations (including laws outside your country of residence), such as those relating to anti-money laundering and anti-terrorism; comply with legal process; and respond to requests from public and governmental authorities (including those outside your country of residence).
- Establish and defend legal rights; protect our operations or those of any of our group companies or insurance business partners, our rights, privacy, safety or property, and/or that of our group companies, you or others; and pursue available remedies or limit our damages.

4. International Transfer of Personal Information

Due to the global nature of our business, for the purposes set out above we may transfer Personal Information to parties located in other countries (including the United States and other countries that have a different data protection regime than is found in the country where you are based). We may transfer information internationally to our group companies, service providers, business partners and governmental or public authorities.

5. Sharing of Personal Information

ILFC may make Personal Information available to:

- **Our group companies**

We may share Personal Information with our parent company, American International Group, Inc., and our other affiliated companies. International Lease Finance Corporation, ILFC Aviation Services (Europe) B.V. and ILFC Ireland Limited are responsible for the management and security of jointly used Personal Information. Access to Personal Information within ILFC is restricted to those individuals who have a need to access the information for our business purposes.

- **Our service providers**

External third-party service providers, include, but are not limited to: providers, such as accountants, auditors, health and welfare benefit providers, lawyers and other outside professional advisors; IT systems, support and hosting services; print management service providers; advertising, marketing and market research and analysis service providers; banks and financial institutions; document and

records management providers; and similar third parties assisting ILFC in carrying out its normal (commercial jet aircraft leasing) business activities.

- **Governmental authorities and third parties involved in court action**

ILFC may also share Personal Information with governmental or other public authorities and third-party civil legal process participants and their accountants, auditors, lawyers and other advisors and representatives as we believe to be necessary or appropriate: (a) to comply with applicable law, including laws outside your country of residence; (b) to comply with legal process; (c) to respond to requests from public and government authorities including public and government authorities outside your country of residence; (d) to enforce our terms and conditions; (e) to protect our operations or those of any of our group companies; (f) to protect our rights, privacy, safety or property, and/or that of our group companies, you or others; and (g) to allow us to pursue available remedies or limit our damages.

- **Other Third Parties**

We may share Personal Information with purchasers and prospective purchasers or other parties in any actual or proposed reorganization, merger, sale, joint venture, assignment, transfer or other transaction relating to all or any portion of our business, assets or stock.

6. Security

ILFC will take appropriate technical, physical, legal and organizational measures, which are consistent with applicable privacy and data security laws. Unfortunately, no data transmission over the Internet or data storage system can be guaranteed to be 100% secure. If you have reason to believe that your interaction with us is no longer secure (for example, if you feel that the security of any Personal Information you might have with us has been compromised), please immediately notify us. (See the “*Who to Contact About Your Personal Information*” section above.)

When ILFC provides Personal Information to a service provider, the service provider will be selected carefully and required to use appropriate measures to protect the confidentiality and security of the Personal Information.

7. Retention of Personal Information

ILFC takes reasonable steps to ensure that the Personal Information we process is reliable for its intended use, and as accurate and complete as is necessary to carry out the purposes described in this Privacy Policy. ILFC will retain Personal Information for the period necessary to fulfill the purposes outlined in this Privacy Policy unless a longer retention period is required or permitted by law.

8. Access and Correction Requests, Questions and Concerns

In certain countries, an individual may have the right to access, correct, object to the use of, or request deletion or suppression of Personal Information on certain grounds. Please contact us as set out in the “*Who to Contact About Your Personal Information*” section above with any such requests or if you have any questions or concerns about how we process Personal Information. Please note that some Personal Information may be exempt from access, correction, objection, deletion or suppression rights in accordance with local privacy and data protection laws.
